



POWER OF ATTORNEY

With Respect to the Financial Transactions Arising from the Investment Agreement Entered Into Between National Bank Financial Inc. and the Immigrant Investor

I, the undersigned, _____, born on _____

_____, hereby appoint **National Bank Financial Inc.**, a securities broker within the meaning of the *Securities Act* (R.S.Q., ch. V-1.1), having its principal place of business at 1 Place Ville-Marie, Suite 1700, Montreal (Quebec) H3B 2C1, hereinafter referred to as the "Agent", with a view to acting for and on my behalf as Agent in order to take any action with respect to the Investment Agreement, and, in particular, I hereby appoint such Agent to:

- deposit, in a separate account opened in my name, the funds which I transferred to the Agent for the purposes of the investment to be made in accordance with section 34.1 of the *Regulation respecting the selection of foreign nationals* and according to the terms of the Investment Agreement;
- effect the following transactions in my account:
 - Transactions listed in the Investment Agreement, including the receipt of the undersigned's funds, the transfer of the funds to IQ Immigrants Investisseurs inc., a subsidiary of Investissement Québec, and any other transaction required under the Quebec Immigrant Investor Program;
 - Management of the funds resulting from the loans, credit margins and other financing options granted to the undersigned, if any;
 - Receipt, acknowledge receipt and deposit any funds received by the undersigned and grant the appropriate waivers and releases;
 - Proceed to the transfer of funds that shall be repaid to the undersigned in the country of origin of the funds, subject to the debts and liabilities incurred by the undersigned; and
 - All other transactions as part of the management of the account by the Agent in the performance of its duties as securities broker in order to give full effect to this power of attorney and to the Investment Agreement. The Agent shall notify me of such transactions as soon as practicable.



- execute, endorse, assign, transfer, deliver, file or record in my name any legal document regarding the investment which the Agent shall deem to be relevant to the investment or to its securities, including documents pertaining to hypothecs granted by the undersigned.
- take delivery and to hold only itself or by an authorized financial institution the note issued by IQ Immigrants Investisseurs inc. until its repayment;
- receive and deposit into my account the sums of money payable to me and acknowledge such receipt;

I declare that this power of attorney may only be revoked if the Investment Agreement is terminated according to its provisions.

This power of attorney is governed by the statutes in effect in the Province of Quebec. Only the courts of Quebec and the Supreme Court of Canada have jurisdiction to decide any dispute which may arise between the parties.
